ENTRY FEES

- **\$65** Early-Bird Entry: April 2 - June 24, 2015. (\$50 for Stephenson County Residents)
- **\$85** Late Entry: June 25 - August 4, 2015 (\$70 for Stephenson County Residents)

Entries which are not accepted will receive a refund minus the \$10 jury fee.

Applications received before June 24th will be notified of their acceptance status after July 31st.

Applications received after June 25th will be notified of their acceptance by August 11th.

ENTRY RULES

- All applicants must be ages 18 or older.
- Art Guilds and organizations which have been established for at least 1 year are also welcome to apply as a group booth. Group applications must include a primary contact.
- All booths must exhibit work of original concept, design and execution. Reproductions and prints should be labeled as such and should not cover more than 25% of the entire display space.
- Media may include all fine arts such as painting, photography, ceramics, jewelry etc.
- Artists and/or group booth members should be present with their booth between 10am and 5pm. With the exception of breaks, artists are expected to be present for customers in their booth throughout the day.
- Artists and/or group booth members must supply their own booth and display setup. The booth display photo provided with the application will be reviewed by the committee.
- Each exhibiting booth space will be approximately 10ft wide by 15ft deep and marked with the assigned booth number. (Fixed elements such as trees in the park may restrict the size of certain spaces.) Booth setup may begin at 6 am on the Sunday of the event. Event Staff will be available at 8 am for check-in.
- Artists and/or group booth members are fully responsible for the care, safety and security of their work and property. The Freeport Park District and the Freeport Art Museum will not be liable for loss or damage to artwork or other property from any cause.

ENTRY INSTRUCTIONS:

- Applications are submitted digitally, online with Entry Thingy. www.artintheparkfreeport.com
Only those with special permission will have the option to submit a paper application.
- Provide a CD with 1 JPEG photo of the entire booth display and 4 JPEG image of the artwork for the booth. Group submissions should submit 4 total images of works by members of the group. Each member *should not* submit 4 images individually.
 - Booth display photos must show the artwork as it will display in your booth.
Do not send pictures of empty booths.
 - All images must be digitized on a CD. Printed photos will not be considered.
- Image dimensions should be between 600-1920 pixels in size. (a 300dpi image at 6in x 4in is about 1800 x 1199 pixels and about a 48k size file)
